INTERPRETATION

PRX c.1102C>T (p.Arg368*), PATHOGENIC

The homozygous c.1102C>T (p.Arg368*) nonsense variant in the PRX gene (MIM:605725) is classified as pathogenic. Pathogenic variants in the PRX gene have been associated with autosomal recessive Charcot-Marie-Tooth disease type 4 and autosomal recessive Dejerine-Sottas disease (1). This variant is predicted to cause premature protein truncation. However, this variant occurs in the terminal region of the gene and the impact of truncation is unknown. Other truncating variants in the PRX gene have also been associated with disease. This variant has been reported previously as homozygous in affected siblings and as heterozygous in trans with (on the opposite chromosome) another likely pathogenic PRX variant (2,3). However, functional studies have not been performed to either support or refute the pathogenicity of this variant. This variant has been observed at a very low frequency in exome and/or genome sequencing data gathered from large, multi-ethnic cohorts, suggesting it is a rare variant (4,5). This result is supportive of a diagnosis of a PRX-related disorder for this individual. Clinical correlation is recommended.

This result should be interpreted in the context of clinical findings, family history, and other laboratory testing.

Consultation with a genetics professional is recommended for interpretation of this result and to determine whether reproductive risk assessment and familial testing may be of benefit to this family. METHOD

Next generation sequencing (NGS) and/or Sanger sequencing was performed to test for the presence of variants in coding regions and intron/exon boundaries of the genes analyzed, as well as some other regions that have known pathogenic variants. The human genome reference GRCh37/hg19 build was used for sequence read alignment. At least 99% of the bases are covered at a read depth over 30X. Sensitivity is estimated at above 99% for single nucleotide variants, above 94% for indels less than 40 base pairs (bp), above 95% for deletions up to 75 bp and insertions up to 47 bp. NGS, and/or a polymerase chain reaction (PCR)-based quantitative method was performed to test for the presence of deletions and duplications in the genes analyzed. Technical Limitations

Next generation sequencing may not detect all types of genomic variants. In rare cases, false negative or false positive results may occur. The depth of coverage may be variable for some target regions, but assay performance below the minimum acceptable criteria or for failed regions will be noted. Given these limitations, negative results do not rule out the diagnosis of a genetic disorder. If a specific clinical disorder is suspected, evaluation by alternative methods can be considered.

There may be regions of genes that cannot be effectively evaluated for sequencing or deletion and duplication analysis as a result of technical limitations of the assay, including regions of homology, high GC content, and repetitive sequences. Confirmation of select reportable variants was performed by alternate methodologies based on internal laboratory criteria.

Additionally, low level mosaic variants may not be detected.

This test is not designed to differentiate between somatic and germline variants. If there is a possibility that any detected variant is somatic, additional testing may be necessary to clarify the significance of results.
