S. pneumoniae IgG Ab,23 serotypes,S

Interpretation

① SDL

Evaluation of the immune response following pneumococcal vaccination can be assessed by measuring serotype-specific Streptococcus pneumonia IgG antibodies. Either of the following conditions is consistent with a normal response to Streptococcus pneumonia vaccination: 1. When comparing pre and post-vaccination samples, antibody concentrations increased by at least 2-fold for either >50% of serotypes in children <6 years of age or >70% of serotypes for individuals >6 years of age. 2. In either a pre- or post-vaccination sample, antibody concentrations ≥ 1.0 mcg/mL for either >50% of serotypes for children <6 years of age or >70% of serotypes for individuals >6 years of age. Results ≥ 1.0 mcg/mL or those showing a ≥ 2 -fold change are consistent with an immune response, but are not necessarily sufficient to provide protection against infection.
