Any immunohistochemistry (IHC)/in situ hybridization (ISH) stain performed as a part of the PATHC will be performed at the reviewing pathologist's discretion at an additional charge.

**Clinical Information**

Keratin 34 beta E12 (sometimes referred to as Keratin 903) is a monoclonal antibody that reacts with high-molecular-weight cytokeratin. In normal prostate, reactivity for keratin 34BE12 can be seen in the basal layer of prostatic glands in a membranous/cytoplasmic pattern. It is most useful as a basal cell-specific marker in the prostate, and shows loss of staining around glands of prostate cancer, which do not have a basal cell layer.

**Interpretation**

This test does not include pathologist interpretation, only technical performance of the stain. If interpretation is required, order PATHC / Pathology Consultation for a full diagnostic evaluation or second opinion of the case.

The positive and negative controls are verified as showing appropriate immunoreactivity.

Interpretation of this test should be performed in the context of the patient's clinical history and other diagnostic tests by a qualified pathologist.

**Cautions**

Age of a cut paraffin section can affect immunoreactivity. Stability thresholds vary widely among published literature and are antigen dependent. Best practice is for paraffin sections to be cut within 6 weeks.

The charge of glass slides can be affected by environmental factors and subsequently may alter slide staining. Sending unsuitable glass slides can result in inconsistent staining due to poor slide surface chemistry.

Best practices for storage of positively charged slides:

- Minimize time slides are stored after being unpackaged
- Limit exposure to high humidity and heat
- Minimize exposure to plastics
